मा. व्यवस्थापन परिषदेने विद्यापीठाकडून आकारल्या जाणा-या संलग्नता शुल्काबाबत ठराव व्य.प.ए.२६८/२००८ नुसार नियुक्त केलेल्या समितीने अध्यादेश १७२ चा सुधारित मसुदा तयार केला असून मा.व्यवस्थापन परिषदेने ठराव क्र. १३८/२००९ नुसार अध्यादेश १७२ च्या सुधारित मसुदयास मान्यता दिली आहे.मा.व्यवस्थापन परिषदेने सदर सुधारित अध्यादेश दि.१४/१०/२००९ पासून लागू करण्याचे निर्देश दिलेले आहेत.

यासंदर्भात प्राप्त निर्देशान्वये कळविण्यात येते की, मा. व्यवस्थापन परिषदेच्या निर्देशानुसार सुधारित अध्यादेश १७२ दि.१४/१०/२००९ पासून लागू करण्यात येत असून सदर अध्यादेशातील तरतुदी शैक्षणिक वर्ष २०१०-११ साठी ऑक्टोबर २००९ मध्ये सादर करावयाच्या प्रस्तावांना व त्यानंतर सादर होणा-या प्रस्तावांना लागू राहतील.



**REVISED ORDINANCE NO.172**  
**ORDINANCE NO.172-A**  
**FEEES FOR NEW AFFILIATION ,CONTINUATION ,EXTENSION,**  
**PERMANENT AFFILIATION FOR COLLEGES**

**(Framed under Sections 28(c), 28(v), 53(xiii), 81(1)(d) (e), 82(3), 83(5), 84,86, 87, 88 of the Act.)**

1. The application form for new affiliation ,continuation of affiliation, extension for affiliation or permanent affiliation shall be submitted to the Registrar of the University in the prescribed form accompanied by affiliation fees as prescribed by the Management Council from time, to time on dates indicated in clause (2) below
2. The last dates of submission of application for affiliation to the Registrar of the university are as under :
  - i) New affiliation
  - ii) Addition of faculty / faculties
  - iii) Continuation of affiliation
  - iv) Extension of affiliation
  - v) Permanent affiliation

On or before 31<sup>st</sup> October  
of the preceding year  
i.e. eight months before the  
commencement of the academic  
year.
3. As per provisions of Section 82, sub section 3 of Maharashtra Universities Act 1994 , no application for new affiliation or addition of faculty / faculties shall be accepted after 31 October of the preceding year.
4. Incomplete applications will be rejected.
5. Duly filled in application for continuation of affiliation not received on or before the prescribed date in clause (2), the same may be accepted by the Registrar, subject to the provisions of Clause (3), on payment of late fee of 5% of the affiliation fees as prescribed in Clause (1), per month. However applications for New Affiliation/Extension / permanent affiliation shall not be accepted in any case, after the due date as prescribed in clause (2) above.
6. In case, the application form for new affiliation, addition of faculty, bifurcation of existing faculty, is not recommended by the University, to the State Govt., the amount of affiliation fees paid by the Society / Trust to the University as prescribed Under clause (1) shall be refunded to the Society / Trust to the extent of 50% only.

In case, the application form for new affiliation, addition of faculty, bifurcation of existing faculty, is recommended by the University to the State Govt. but is not approved by State Govt. the amount of affiliation fees paid by the Society / Trust to the University as prescribed under clause (1) shall not be refunded in any case.
7. The fees paid under clause (1), for permanent affiliation, continuation affiliation, Extension of affiliation shall not be refunded in any case.
8. The affiliation fees as prescribed under clause (1) and late fees as per clause (6) above shall be paid by means of demand draft drawn in favour of the Registrar, North Maharashtra University, Jalgaon.

**ORDINANCE NO.172-B**  
**ANNUAL AFFILIATION FEES**

- 1) Colleges having permanent affiliation for courses run by them, shall pay to the University Annual Affiliation Fee per course at the rates, as prescribed by the Management Council from time to time.
- 2) If the University grants the continuation of affiliation for more than one year to the courses of the college, such college shall pay Annual Affiliation Fees for these courses to the University for each Year at the rates, as prescribed by the Management Council from time to time.
- 3) The prescribed Annual Affiliation Fees shall be paid on or before 31st October of the preceding year.
- 4) In case, the fees not paid on or before the due dates, the college shall be charged late fees, at the rate of 2 % of the annual affiliation fees per month.
- 5) The annual affiliation fees as prescribed under clause (1) and late fees as per clause (4) above shall be paid by means of demand draft drawn in favour of the Registrar, North Maharashtra University, Jalgaon.

**ORDINANCE NO.172-C**  
**RECOGNITION OF INSTITUTION**

1. The application form for Recognition of Institution shall be submitted to the Registrar of the University in the prescribed form accompanied by affiliation fees as prescribed by the Management Council from time to time on dates indicated in clause (2) below
2. The last dates of submission of application for Recognition of Institution to the Registrar of the university are as under :

i) New Recognition of Institution	}	On or before 31 <sup>st</sup> October of the preceding year i.e. eight months before the commencement of the academic year.
ii) Continuation of Recognition of Institution		
iii) Extension of Recognition of Institution		

3. No application for new Recognition of Institution shall be accepted after 31<sup>st</sup> October of the preceding year.
4. Incomplete applications will be rejected.
5. Duly filled in application for continuation of Recognition of Institution not received on or before the prescribed date in clause (2), the same may be accepted by the Registrar, subject to the provisions of Clause (3), on payment of late fee of 5% of the affiliation fees as prescribed in Clause (1), per month. However applications for New Recognition of Institution, Extension of Recognition of Institution shall not be accepted in any case, after the due date as prescribed in clause (2) above.

6. The fees paid under clause (1), for Recognition of Institution shall not be refunded in any case.
7. The affiliation fees as prescribed under clause (1) and late fees as per clause (6) above shall be paid by means of demand draft drawn in favour of the Registrar, North Maharashtra University, Jalgaon.

**ORDINANCE NO.172-D**  
**RECOGNITION OF LABORATORIES / RESEARCH CENTRES**

1. The application form for Recognition of laboratories / Research Centres of the affiliated colleges for carrying out Research shall be submitted to the Registrar of the University in the prescribed form accompanied by affiliation fees as prescribed by the Management Council from time to time, before 31<sup>st</sup> October of the preceding year.
2. No application for new Recognition of laboratories / Research Centres shall be accepted after 31<sup>st</sup> October of the preceding year.
3. Incomplete applications will be rejected.
4. Duly filled in application for continuation of Recognition of laboratories / Research Centres not received on or before the prescribed date in clause (1), the same may be accepted by the Registrar, subject to the provisions of Clause (3), on payment of late fee of 5% of the affiliation fees as prescribed in Clause (1), per month.
5. The fees paid under clause (1), for Recognition of laboratories / Research Centres shall not be refunded in any case.
6. The affiliation fees as prescribed under clause (1) and late fees as per clause (6) above shall be paid by means of demand draft drawn in favour of the Registrar, North Maharashtra University, Jalgaon.

**ORDINANCE NO.172-E**  
**RESERVE FUND, BUILDING FUND, LABORATORY FUND, LIBRARY  
AND DEFICIT FUND**

- 1) After receipt of new affiliation to the college from the University, every newly affiliated College / Recognised Institution shall build up the Reserve fund, Building fund, Laboratory fund, Library fund and Deficit fund as prescribed by the Management Council from time to time
- 2) The funds so built up shall be maintained by the college for the period of 10 years or upto the grant of Permanent affiliation by the University to the college, whichever is earlier
- 3) The funds so established shall be deposited in the nationalized banks on the joint account of Registrar, North Maharashtra University, Jalgaon, Chairman, concerned institute and Principal / Director, of concerned College / Institute.

**ORDINANCE NO.172-F**  
**RULES TO OPERATE THE ACCOUNTS OF RESERVE FUND, BUILDING FUND, LABORATORY FUND, LIBRARY AND DEFICIT FUND**

**1) BUILDING FUND:**

- a) The college may request the University to withdraw the amount from the building fund for construction of a building required for the college. With the approval of the University the college shall be entitled to withdraw not more than 90% of the amount deposited.
- b) The withdrawal may be sanctioned on receipt of a certificate from a Chartered Engineer, giving the valuation of the construction work already completed, in respect of which the application for withdrawal has been made.
- c) Request for withdrawal from the Building Fund may be granted only if the- amount so withdrawn is intended to be utilized for building work relating to college and for no other purpose. However, if the required building is completed, the amount so withdrawn can be used only for the college development.

**2) DEFICIT FUND:**

The college may withdraw the part of the amount with the permission of the University for the reasons' that may be prescribed by the University from time to time, upto a limit that may be approved by the University. Provided, that the amount so withdrawn shall be reimbursed to the deficit fund within a period prescribed by the University.

**3) RESERVE FUND:**

- a) The extent of withdrawal from the Reserve Fund shall be determined by the Management Council.
- b) The College Management shall undertake to reimburse the amount withdrawn, in a manner to be determined by the Management Council of the University, on studying the circumstances of each individual case. If the college is permanently affiliated or produces satisfactory evidence of its financial stability for the continued maintenance of the college, the Management Council may not insist upon the reimbursement of the amount withdrawn.
- c) After the Reserve Fund as laid down in ordinance has been once established and deposited by the college, the Management Council of the University may allow the college to withdraw from the Reserve Fund permanently an amount not exceeding half of that amount for recurring expenditure of permanent nature in connection with the development and stabilization of the college.

**4) LIBRARY FUNDS / LABORATORY FUNDS:**

If the college is permanently affiliated or produces the statutory evidence of its financial stability for the continued maintenance of the college, the management council of the University may allow the college to withdraw from Library / Laboratory funds permanently, an amount not exceeding half of that amount for recurring expenditure of permanent nature in connection with the development of the Library / Laboratory.

5) GENERAL RULES:

- 1) All such funds prescribed above shall be deposited with the nationalized bank in most beneficial manner in joint account to be operated with the signatures of Registrar, North Maharashtra University, Jalgaon, Chairman, concerned institute and Principal / Director, of concerned College / Institute.
- 2) Bank Guarantee in lieu of the deposits shall not be accepted.
- 3) Management Council of the University shall be the competent authority to permit withdrawals from the funds after framing specific conditions to do so.
- 4) All such funds prescribed above shall be maintained till the permanent affiliation is granted to the college by the University.
- 5) All such funds prescribed above shall reflect in the budgetary provision of the institutions.
- 6) The college shall not draw any overdraft against such deposits.
- 7) A disciplinary action shall be initiated against a college on violation of any of these rules.
